

### Missouri Laws

#### Family planning and contraception

- No law explicitly allows all minors to consent to contraceptive services
- Minors who are married may consent to contraceptive services

#### Pregnancy testing and prenatal care

- Any minor may consent to pregnancy testing and all other medical care related to pregnancy (excluding abortion).
- Physicians may inform parents (unless it is a Title X clinic)

#### STD Testing

- Any minor may consent to testing and other medical care related to STDs
- Physician may inform parents (unless it is a Title X clinic)


#### Rape or Sexual Assault

- Minor victims of rape or sexual assault may consent to a forensic medical examination. However, the hospital or physician conducting the exam must give written notification to a parent or guardian that the exam has occurred
- Abortion services
  - Must have written parental consent unless the minor is emancipated or judicial bypass is granted. 72 hour waiting period and in-person counseling session

## **Youth-Friendly Services Defined**

Youth-friendly health care services are those that attract young people, respond to their needs, and retain young clients for continuing care.

The goal is to provide young people with services they trust and which they feel are designed for them.

## **Assessment Categories**

- Accessible location and hours, including transportation
- Warm and respectful environment
- Confidentiality and Privacy

- Cultural and Linguistic Appropriateness
- Parent/Guardian Involvement
- Support for Abstinent Youth

#### **Health Center Key Informant Interview Guide**

"This interview includes questions in 8 categories: confidentiality, privacy, consent, cultural and linguistic appropriateness, comprehensiveness of services, parent / guardian involvement, accessibility, support for abstinent youth."

## **Organizational Action Steps**

- **1. Assess** buy-in at every level.
- 2. Assess your community partner organization's ease of access, location, transportation options, accessibility, and receptiveness of staff.
- **3. Know** your school's policies regarding referrals and parent involvement
- 4. Develop, disseminate referral guide to colleagues, youth & families.
- 5. Identify, train key staff on new policies, guide and referral protocols.
- **6. Evaluate** referrals and repeat assessments & training annually or as needed.
